**PUBLIC UTILITY LAW JUDGE’S NOTICE  
OF PUBLIC COMMENT HEARINGS**

On December 21, 2018, Baltimore Gas and Electric Company (BGE) filed an application (“Application”) for a Certificate of Public Convenience and Necessity (CPCN) for authority to modify a portion of an existing 230 kV electric transmission line that runs between the Riverside Substation in Baltimore County, Maryland, and the Brandon Shores Substation in Anne Arundel County, Maryland.<sup>1</sup> BGE proposes to replace the existing underground pipe-type cable along an approximate 2.25-mile stretch of the existing 230 kV electric transmission line between Hawkins Point and Sollers Point beneath the Patapsco River with overhead wire and eight support structures.

Evening hearings for the purpose of receiving public comments in connection with the Application are hereby scheduled as follows:

Commenters utilizing the Public Comment Dropbox are required to complete a one-time registration. All comments must include a reference to Case No. 9600. If submitted by first-class mail or hand-delivery, comments must be addressed to Executive Secretary,

16th Floor, Baltimore, Maryland 21202. Only one copy is required.

BGE is hereby directed to:

- Once in each of the four successive weeks immediately before the first evening hearing date:

Publish notice of each of the public hearings, including the caption, case number, time, date, location, and the purpose of the hearings, as a display advertisement in a newspaper of general circulation throughout Baltimore City and Anne Arundel and Baltimore Counties; and

Post on at least two routinely used social media platforms, such as Facebook or Twitter, and use any other means of communications at its disposal to further notify Baltimore City, Anne Arundel and Baltimore County residents of the date, time, and location of the public hearings, and the date by which written public comments may be filed.<sup>2</sup>

- At least four weeks prior to the date of the first public hearing until the day after the last public hearing, post on the home page of its website page, a notice of the public hearings in a manner so that an individual need not click the link to determine the date, time, location, and purpose of the hearings, and the date by which written public comments may be filed.
- File a certificate(s) of publication and postings with the Commission on or before the date of the first public hearing.
- Prominently post on the day of each public hearing, no later than noon (EST), an informational sign at or near the public entrance(s) of the building(s) in which the public hearing(s) will be held. Each sign shall be at least 17 inches by 22 inches in size and state the time, room, and subject of the public hearing. The font size of the lettering

shall be greater than 48-point size and as large as the sign allows. BGE shall submit an affidavit certifying that the necessary properly sized informational sign(s) were posted, as directed, including the time the signs were posted and a photograph of the informational sign near or at the public entrance(s) of the building(s) in which the public hearing(s) are held, which shall be filed with the Commission within two business days after the last public hearing.
